- Last year, the Oklahoma Chapter of SLA sponsored three workshops and seminars:
 - 1. The first was a hands-on workshop at the Oklahoma Department of Libraries on *Circulating Book Repair* conducted by **GARY HARRINGTON** from the State Archives.
 - 2. A highly successful Information Vendor Expo was held at the Rogers University Conference Center. Representatives from leading information vendors; the Bureau of National Affairs (BNA), LEXIS-NEXIS, EBSCO, and Information Handling Service gave demonstrations of their products, provided attendees with information about their products and answered questions of concerns to librarians dealing with increasing electronic media.
 - **3.** The third program was held in conjunction with the annual meeting. This program featured **LESLIE MILLER**, Oklahoma State University Safety Training Coordinator. Her topic was *Fire Safety* followed by a hands-on opportunity to practice extinguishing fires using the three types of extinguishers.

ELECTRONIC RENEWAL IN AN ACADEMIC LIBRARY

Like most academic libraries, OSU has expanded its use of the Internet to provide services to its users. Initially, we focused on web page development and remote access to reference services, the online catalog, and databases. In 1997, the Access Services Department, which includes circulation, responded to user demands by making it possible to renew books via E-mail and the Web.

Before automation, renewing materials involved a trip to the library or submitting a list of books with call and accession numbers. With the advent of automation, the OSU library added phone renewals. Phone renewals are limited to 10 items per call. Users read the barcodes and library staff key those numbers in one at a time. It is a time-consuming process and when we are busy at the circulation desk, the phone rings off the hook!

In April, we began offering the option of sending a list via E-mail. We had a circulation mail box set up and contacted several patrons who consistently used the phone renewal service and asked them to try renewing via E-mail for a couple of weeks. Once we had formulated a procedure which worked for us, we posted the E-mail address at the circulation desk, and gave it out over the phone as the opportunity arose when people called to renew their books. Users email us a list with their name, ID number, and the bar codes of the items they wish to renew. We send them an E-mail confirmation and a printed list of all the books they have checked out along with the due dates. If for some reason we are unable to renew an item, for example, it has been recalled or is a reserve book, we send them a message indicating the item was not renewed and why.

Next a Web form was created with blanks for user name, ID number, E-mail address, and the bar codes of the books they wished to renew. The form is accessed from the library's home page (www.library.okstate.edu). Initially, we set the Internet form to allow 10 bar codes and we have subsequently increased the number to 40. If a user has more than 40 books to renew, s/he can use multiple forms. We send an E-mail confirmation that the request was received and processed and that a printed copy of everything they have checked out will be sent via snail mail.

Some problems occur when a user claims to have sent a request via E-mail or Web but it didn't get done. The recall/renewal assistant who manages this service keeps an archival copy of each request received. Because transmission errors do occur, we credit intent with the same value as action, until it becomes obvious to us that the individual is attempting to "work the system." This has not been a significant problem.

We have done a number of things to promote the use of electronic renewals. In the fall, we printed bookmarks informing users of all the ways to renew books, but emphasizing E-mail and Web. Bookmarks are place in books being checked out. We also tell people renewing in person about the service and give them a bookmark as well. That is most effective when the person renewing in person is also paying a fine!

The electronic renewal service has been well received. Phone and E-mail renewals have remained fairly constant, while Web renewals have increased significantly. List and fax renewals have dropped to nearly zero. The ease of electronic renewals has led to requests for other Internet services from circulation. We are examining electronic recall requests and are considering it for fall.
