3. Library Carpentries Workshop Update

Kay is working on setting up a website, similar to their other Carpentries events they have held. Karl is working on a registration form through the OK-ACRL website. This will take place the mornings (½ days) of June 18-19. The website and registration websites should be in place next week, with a maximum enrollment of 15 and a wait list of 5 people. The cost will be free.
